- a. Fire Chief Report: JULY 2019
- 1. **Fire Defense Board Appointment** The Fire Authority had a special meeting on June 27 to confirm the support of the Fire Authority for my appointment to the Fire Defense Board. There

was a request at that time to provide a little information regarding FDB and what the role is as well as my role.

Fire Defense Board (FDB) is a statewide requirement of the Mobilization plan and under the State Fire Marshal's office and rule. We as fire chiefs come together as a team to represent the county to deal with trending issues as well as representation for conflagration and such.

Fire Defense Board is funded by dues on a small level from each District and then from Fire Med dues received. We don't expend much money but can and will related to county wide issues as well as other small services.

My role for FDB will be Secretary as well as a member of the Base 1 Overhead team in-county. I'll assist in coordination as needed to support the other members but will not be deployed out of county any different then now. I look forward to this role and opportunities to come with it.

- 2. **Certification of Election** We received our action items for the certification of the previous election which has been subsequently completed and submitted back to Lane County. New members have received certificates from the County tonight.
- 3. **Fire House Subs Grant** I have received turn-down notification from Fire House Subs from the last grant request for Extrication Equipment. Off to try again!
- 4. **June Fiscal Year End** We spent June winding down the fiscal year and preparing the list of needs form our new auditor who will be starting the audit in August this year. We look to be in great shape with all three budgets on track to end above expectation for carry-forward amounts. I am pleased by our continual healthy fiscal positioning.
- 5. **Swearing In** On June 27th we proudly swore in 8 new members joining our organization as firefighters and EMT's. They have all begun their service on shift helping with our daily staffing model. We are currently recruiting for 2 resident volunteer position openings and hope to find candidates this summer as the school year begins.

CHIEF UPDATE: Chief Smith let the boards know that he has just received notification that Pleasant Hill Goshen Fire & Rescue has been awarded an ODF 50/50, \$7,700.00 grant which will be used to purchase fire shelters, wildland compliant pants and gas-powered pole saws.

b. Division Chief's Report

July Presentation of Operations and Training in June

Operations:

In July we received a total of 80 calls for service from all three stations in both battalions combined. This gave us an average of 2.66 calls per day. Battalion 51 had 47 emergency calls, and Battalion 52 had 19 calls. In addition to these calls for service, 14 more were received in neighboring districts. In total, our staff and volunteers responded to 39 EMS calls, 17 MVA, and 19 fires. In addition to these emergency calls, we received 5 calls that I classified as "other" or

"special rescue" which were generally calls for us to isolate and deny entry to downed power lines, and of course water rescues.

Training:

We have concluded our most recent apparatus operator academy, and the testing process will be held July fifth. The scheduling process for our Fall academy has begun, and I hope to have dates finalized with the other training officers on the Hwy 58 corridor prior to August.

Looking forward to July, we have Life Flight scheduled for a special presentation of hands on training as well as some extensive classroom training on landing zone safety and patient transfer techniques.

Division Chief Barnhart explained to the boards the information that is presented in his report.
