Review of Monthly Financial Reports

Chief Smith let the boards know that the audits are coming in and should be available in the coming week. Discussion regarding the audits will likely be on next month's agenda. He updated the boards on PERS explaining that corrections are being made to our records with PERS due to the discovery that at some of our reporting to PERS was done incorrectly or not reported at all. This project was discovered during PERS training, as well as the PERS audit of a recent retiree account. This project includes dates going back to the earliest payroll records we have retained. Although there is not a current projected amount, both districts will end up owing PERS additional money due estimated in the thousands. Willie Bronson asked for a status on the new Tahoe and surplus of current Tahoe. Chief Smith stated he is just waiting for the call anytime that the new Tahoe is ready, and that Dexter Fire is interested in purchasing our current command vehicle. Chief explained possibly \$15,000 was the amount discussed due to researching comparable vehicles.

- a. Fire Chief Report: November 2019
- 1. **Recap of Some Significant Incidents for September** Here is a quick look at a few of our more serious incidents handled by or responded to by Pleasant Hill Goshen Fire & Rescue.
 - a. **10/5/2019** 4.5-acre brush/slash fire in Marcola, provided a crew to assist. This was also an FDB Base 1 incident managed by myself on site.
 - b. **10/10/2019** Just an example of our increasingly busy days as we had 5 calls this day, all staffed well.
 - c. 10/15/2019 Excavator fire in a storage yard for a business, the response from PHG was two engines and two chiefs with a total of 9 on scene in under the 14-minute threshold.
 - d. **10/19/2019** Mobile Home fire in Dexter, provided two tenders and kept an engine available for coverage. Chief officer to the scene. Home a total loss.
 - e. **10/28/2019** Fire in a mobile home in PH responded with engine and chief, fire extinguished by Chief on arrival 5 minutes after dispatch. Electrical fire in the residence.
 - f. **10/29/19** Brush fire, 7 acres in Blue River, Base 1 activation managed by myself with a brush rig assisting above our normal staffing from PH. This was in addition to the engine that was in California and we still had a Chief and 4-person crew in quarters during this incident.
- 2. **Grant Status AFG** We did receive notice that we were not funded on our grant request to AFG. Time is already here to reapply for the next year of AFG which I will be completing very soon. I have submitted again for the Fire House Subs grant for extrication equipment which is a 100% funded grant usually up to about \$25,000.
- 3. **Billing/Cost Recovery** I was asked for a status check on our billing for the fiscal year for cost recovery on incidents such as MVA's. At the time of writing this, we have billed out \$2,869.50 for cost recovery per our policy and we have received \$494.00 so far. Some of these take time for insurance to pay out etc. We have a practice of sending reminder notices before evaluating any of them that may be referred to our collection agency. We have had a couple be collected on from that agency as a result.
- 4. **Fire Station Fire Alarm System** Alarm and sprinkler system testing, and servicing was conducted this month at the Goshen station. We had unknowingly become behind on some of this service which has now been caught up and is on a regular schedule.

CHIEF UPDATES: Chief Smith updated the boards on conflagration explaining the crew was back and did well, along with our apparatus. They were on conflagration for 8 days. Chief Smith explained there is no Division Chief Report this month due to his being back east for training followed by his deployment to California.
